EXECUTIVE SESSION #1

A. The Salem Area Mass Transit District Board of Directors will meet to evaluate the performance of the General Manager pursuant to ORS 192.660(2)(i)

Only the Board of Directors and designated staff, and representatives of news organizations and media are permitted to attend the executive sessions pursuant to ORS 192.660(4). Attendees are respectfully directed not to report on any of the discussions that occur during the session, except to state the general subject.

No final action or decision may be taken in executive session.

If the Board needs more time for discussion in either of these executive sessions, they will call for a recess at the end of the regular board meeting and proceed to meet in executive session again. If there are any decisions to be made or action to take place, the Board will conduct this business upon returning to the regular Board meeting; otherwise, the meeting will be adjourned.
