- KTC construction begins January 2023, Finishes March 2023
- ChargePoint charger arrive January 2023
- Del Webb construction (first part) starts January 2023 ends March 2023 (The switchgear has up to a 52 week lead-time) causing the vendor to install this equipment when it arrives. This could be up to August of 2023.
- Construction at KTC appears to be on track to align closely with bus delivery.
